## President's Report 2021/22

## Meetings with the Intellectual Property Department ("IPD")

We had several meetings with the IPD in the year 2021/22:-

## Amendments of Trade Marks Rules

IPD is working on amending the Trade Marks Rules to include provisions on the implementation of the Madrid Protocol as well as amending the rules regarding hearing procedures. IPD is working

towards the target of submitting the amendment bills to LegCo for negative vetting during the 2023 legislative year.

# Proposal for verification of Hong Kong based "Agents" under the Trade Marks Ordinance

In recent years, it has been discovered that overseas-based businesses and individuals have purported to be and acted as local "Hong Kong agents" through a "company secretarial service provider" or similar with no real physical presence in Hong Kong. It appears that the IPD is not enforcing section 88 (3) of the Trade Marks Ordinance which provides that "The Registrar shall refuse to recognise as an agent a person having neither residence nor a place of business in Hong Kong".

Together with APAA and IPLS, the Institute worked together on a written submission to the Commerce and Economic Development Bureau ("CEDB") and IPD on 14 February 2022 to express practitioners' concerns regarding service providers that handled trade mark matters without a place of business in Hong Kong.

Representatives of the three professional members met with IPD on 12 May 2022 to discuss the matter. Prior to the meeting the three professional bodies compiled a list of 16 agents which appeared not to have a place of business in Hong Kong. At the meeting, IPD claimed that section 88 and Rule 103 are sufficient and do not see a need to amend the existing provisions. They claim that they will take more 'robust' measures such as amending the Work Manual and specify the requirements for physical presence of local agents. IPD claimed that they will also look into the list of e-filers with no real Hong Kong presence that we provided.

At the meeting, IPD mentioned a complaint about an agent with no physical presence in Hong Kong that they received in February 2022. IPD made some inquiries with the agent. Eventually, the agent had to transfer 5000 plus trade marks and designs records to another agent. IPD urged practitioners to inform them if they are aware of any agents that do not have any physical presence in Hong Kong. IPD affirmed that simply having a Business Registration certificate and virtual offices are not acceptable.

On 29 June 2022, the three professional bodies worked together and produced a supplemental submission to CEDB and IPD with further examples of 35 additional questionable agents and requested another meeting with IPD.

Another meeting was held with IPD on 31 August. IPD reported that out of the 51 agents drawn to their attention, IPD was carrying out investigations into 32 cases; and out of the 19 companies that were investigated, no action was taken against 10 agents while 9 agents were considered as not having a principal place of business in Hong Kong. IPD also reported that enhanced measures to strengthen enforcement of section 88 (3) of the TMO were in progress:

- conducting robust investigations and enforcement under s.88(3) of TMO
- conducting proactive enquiries about agents opening e-filing accounts
- to update TM Registry Work Manual to reflect the enhanced practice of TM Registry
- to update the current e-filers list for identifying which ones are legally qualified
- to set up dedicated webpage about agents
- to highlight the statutory requirement on agents via appropriate means (e.g. IPD & WIPO's websites, correspondences on office actions, promotional materials) of preparing the implementation of Madrid Protocol
- to collaborate with IP bodies in:

- promoting HK quality professional services
- organizing possible training courses
- Updating of trade mark forms with inclusions of statutory requirements, declaration and warning:
  - (i) Applicable to e-filers and paper filers alike
  - (ii) Highlighting statutory requirements for agent to provide its residential/business address in Hong Kong
  - (iii) Agent is required to declare that the address so provided is where agent resides or carries on its business activities in Hong Kong, and that such declaration is true and accurate
  - (iv) Inclusion of a specific warning to the effect that making a false declaration is an offence which is liable to criminal prosecution

In addition, IPD is considering the following enhanced measures:

- a. to introduce an express statutory requirement for an agent, when notifying the Registrar of its address under r.103(3)/(4) of TMR, to declare that such address is a place where it resides or carries on his business activities in Hong Kong, and that such declaration is true and accurate.
- b. to highlight the Registrar's power to direct filing of documents, information or evidence as proof of an address provided under r.103(3)/(4) of TMR if he thinks fit.
- c. discussing with DOJ about possible amendments to highlight the key pointer which the Registrar, when considering any document, information or evidence filed by an agent pursuant to the Registrar's direction, may take into account whether the documents indicate that "the agent has a physical residence or place of business in Hong Kong.

This year's BIP Asia Forum will take place on 1 and 2 December 2022 in person and on-line, and the Institute will once again be a supporting organization of the forum.

#### Webinar

Since last year, the Institute has organized online webinars in place of in-person lunchtime seminars. This year, we had the pleasure of having Mr Kenneth Lee and Mr William Tse to present an online seminar on the topic of "METAVERSE, TRADE MARKS & ANTITRUST".

In October this year, Sebastian Hughes presented a seminar on on the topic of "The Exhaustion of Rights Defence – Recent Case Law" that included analysis of similar statutory provisions in Singapore (upon which the Hong Kong provision is based) and the United Kingdom, and relevant case law – including the Singapore Samsonite decision; and the decision of Laddie J in *Zino Davidoff SA v A&G Imports Ltd.* 

The Institute have not applied for CPD accreditation for our webinars. Members are however reminded of the Law Society's guidelines in respect of a deemed accreditation system. Specifically, a solicitor or trainee solicitor subject to the CPD Rules Cap. 159W may, out of the annual CPD requirement of 15 CPD points, claim a maximum of 3 CPD points per CPD practice year by attending courses which fulfil the accreditation criteria prescribed under the deemed accreditation system stated in the CPD Information Package.
