Meetings with the Intellectual Property Department ("IPD")

We had several meetings with the IPD in the year 2022/2023:-

- A. Joint Meeting between HKITMP, APAA, Law Society IP Committee ("IPLS") and IPD (23 March 2023)
- B. Patent Practice Group Meeting (27 March 2023)
- C. Briefing on the proposed amendments to the Rules of the High Court concerning IP Proceedings before the Court of First Instance and proposed additional complementary and incidental amendments to TMR, PGR & RDR (16 June 2023)
- D. Trade Mark Practice Group Meeting (31 August 2023)
- E. Briefing session on registered design fees (31 August 2023)

A. Joint Meeting between HKITMP, APAA, Law Society IP Committee ("IPLS") and IPD

In the Joint Meeting, IPD provided updates on the following issues:

- a) There has been a decrease in the number of filings for trade marks and patents with a slight increase in short term patents.
- b) The IPD will be adjusting the official fees for patents and registered designs with preferential rates for e-filings.
- c) The IPD will be updating the official forms to encourage applicants to provide the place of incorporation.
- d) To cater for the implementation of the Madrid Protocol, IPD will be updating the official forms
- e) IPD had investigated 59 agents suspected of not having an actual place of business in Hong Kong and 19 agents were refused recognition.

B. Patent Practice Group Meeting (27 March 2023)

IPD invited the Institute together with 5 other organizations namely, APAA-HK, LawSoc-IP, Hong Kong Institute of Patent Attorneys Limited ("HKIPA"), Hong Kong Institute of Patent Practitioners Limited ("HKIPP") and the Hong Kong Chinese Patent Attorneys Association (HKCPAA") to this meeting.

I attended the meeting with Valerie Suen and Jeffrery McLean. At the meeting, IPD sought practitioners' views on adding a "List of Persons in HK with Patent Agent Qualification" on its website. The list will contain persons residing in Hong Kong and qualified to lawfully provide patent agency services in jurisdictions outside Hong Kong.

Practitioners commented that the public may mis-interpret the list as having been endorsed by IPD and urged the IPD to consider setting up a register of qualified persons to regulate patent agents. The HKIPA, the HIPP and the HKCPAA have prepared a discussion paper covering a grandfathering scheme for "registered patent agents" and a new qualifying scheme for "registered patent attorneys". However, the paper was only made available to attendees of the meeting.

C. Briefing on the proposed amendments to the Rules of the High Court concerning IP Proceedings before the Court of First Instance and proposed additional complementary and incidental amendments to Trade Marks Rules, Patents (General) & Registered Designs Rules (16 June 2023)

The IPD held a briefing on the legislative exercise for introducing three new Orders into the Rules of the High Court ("RHC") and the amendments to the Trade Marks Rules, Patents (General) Rules and Registered Designs Rules.

IPD provided drafts of the above-mentioned proposed amendments, on a "restricted" basis, to the Institute and other professional bodies to solicit the professional bodies' views. Valerie Suen, Benjamin Choi, Helen Tang, Loretta Lau, Jacqueline Chu and I worked together and put forward comments on the proposed amendments on behalf of the Institute.

This year's BIP Asia Forum will take place on 7-8 December 2023 and the Institute will once again be a supporting organization of the forum.

Seminars

We will host a lunch seminar at Deacons on 31 October 2023. We have invited Ms. Stephanie Wong, barrister at Des Voeux Chambers, to be the speaker. Stephanie will talk about various topics of current interest including on e-commerce platforms and joint liability issues, the jurisdictional issues arising out of online sales of infringing materials available to buyers in Hong Kong but which are hosted by platforms owned by entities overseas (e.g. China or elsewhere), and the Mary Kay/Taobao and Tmall case.

The Institute has not applied for CPD accreditation for our webinars. Members are however reminded of the Law Society's guidelines in respect of a deemed accreditation system. Specifically, a solicitor or trainee solicitor subject to the CPD Rules Cap. 159W may, out of the annual CPD requirement of 15 CPD points, claim a maximum of 3 CPD points per CPD practice year by attending courses which fulfil the accreditation criteria prescribed under the deemed accreditation system stated in the CPD Information Package.
