# President's Report 2020/21

I have the pleasure of delivering my second President's Report for the Institute.

### Meetings with the IPD

We had several meetings with the IPD in the year 2020/21:

- 1. Joint Meeting between HKITMP, APAA, Law Society IP Committee and IPD (originally scheduled for 8 December 2020 and postponed to 1 February 2021).
- 2. Original Grant Patent Meeting (1 February 2021).
- 3. National 14<sup>th</sup> Five Year Plan / IP Trading Hub Meeting (29 April 2021).
- 4. Online Search System Meetings (18 May 2021 and 4 June 2021).
- 5. Trade Mark Practice Group Meeting with IPD (joint meeting including HKITMP, APAA, Law Society IP Committee) (20 August 2021).
- 6. HKITMP and IPD Annual Meeting (28 September 2021).

One of the major tasks the IPD is focus on now is the implementation of the Madrid International System for Registration of Trade Marks. The IPD reported that in 2021, it would be working with the Law Draftsman to draw up the provisions of the new set of subsidiary legislation for trade marks with a view to tabling it before LegCo for negative vetting within 2022. The IPD expects to prescribe new fees for the domestic and international registration systems and will enhance the IT system to provide a new electronic communication gateway with the World Intellectual Property Organization (WIPO). This communication gateway will be used for receipt of future incoming international applications designating Hong Kong and the handling of other post-registration matters. The IPD targets to launch the international registration system by 2022-23.

The IPD also shared some projections on the number of filings and requests under the new international registration system:-

(i) some 200 applications for international registrations might be filed with the

International Bureau of WIPO through the Trade Marks Registry (as Office of Origin); and

 some 7,000 requests might be received by the Trade Marks Registry (as Designated Office) for extension of protection of international registrations to Hong Kong.

# Events

### Webinar

Since last year, the Institute has organized online webinars in place of an in-person lunchtime seminar. This year, we had the pleasure of having Katrina Lee (barrister) speak to our members on "*Sky PLC v Skykick UK Ltd: Paving the way* to "decluttering" the trade mark register?" on 26 August 2021.

The Institute have not applied for CPD accreditation for our webinars. Members are however reminded of the Law Society's guidelines in respect of a deemed accreditation system. Specifically, a solicitor or trainee solicitor subject to the CPD Rules Cap. 159W may, out of the annual CPD requirement of 15 CPD points, claim a maximum of 3 CPD points per CPD practice year by attending courses which fulfil the accreditation criteria prescribed under the deemed accreditation system stated in the CPD Information Package.
